

## **CONTRATO HONORARIO (NO REMUNERADO) DE JUNIOR UCI FELLOW CON EL HOSPITAL KING'S COLLEGE NHS TRUST FOUNDATION**

King's College NHS Trust Foundation es uno de los complejos hospitalarios más grandes de todo el Reino Unido, con fuertes lazos con la Universidad King's College de Londres. Buscamos a residentes de Medicina Intensiva en sus 12-18 últimos meses de formación MIR que deseen trabajar como Junior Fellows . Se ofertan contratos mínimos de 3 a 6 meses de duración.

El departamento de Cuidados Intensivos ofrece la posibilidad de venir a rotar (como parte del programa MIR español) y a participar en las actividades diarias de una de las UCIs con mayor actividad clínica y de investigación de la ciudad de Londres. Para ello es necesario obtener un contrato honorario (no remunerado) con unos requerimientos particulares. El objetivo es proporcionar esta posibilidad de manera regular a lo largo del año siendo las fechas ideales la primera semana de Febrero o Agosto, pero existe flexibilidad dependiendo de la disponibilidad de los candidatos.

El hospital King's College de Londres es uno de los grandes centros de referencia del país con actualmente 70 camas de cuidados críticos y en plena expansión, se espera una capacidad de hasta 120 camas en los próximos dos años. Es centro de referencia mundial para el trasplante hepático (con unos 250 anuales) y centro de politrauma.

### **“Oferta y requerimientos”**

El contrato laboral de Senior Fellow requiere **colegiación con el General Medical Council** para poder atender pacientes y participar en la rotación como un miembro más del equipo además de haber superado una **entrevista de selección** entre los candidatos presentados. La entrevista se podría realizar incluso vía video conferencia (“Skype”).

Nuestra responsabilidad como tutores clínicos del Fellowship es facilitar la información sobre los requerimientos, sistema de selección y ayudar en la medida de lo posible con la tramitación.

Como Junior Fellow, ofrecemos no solo la posibilidad de participar en la actividad clínica diaria, sino también en reuniones del departamento, cursos, investigación, “*grand rounds*”, sesiones sobre tópicos relevantes y por descontado vivir en una de las ciudades más vibrantes y cosmopolitas del mundo.

Para poder trabajar en el Reino Unido es necesario colegiarse con el General Medical Council (GMC). El proceso no es complicado pero es importante cumplir todos los requisitos. La sección que hace referencia al GMC concretamente es: **applying for registration with a licence to practise** – for nationals from the EEA, Switzerland and other doctors with EC rights, who graduated at EEA or Swiss medical schools and have not completed an internship.

### **Los requerimientos son los siguientes para la colegiación:**

1. Pagar la cuota £425 y abrir una cuenta online con el GMC.

2. Pasaporte válido o DNI
3. IELTS académico con una nota mínima de 7 en cada apartado y media total de 7.5. Como ciudadanos de la UE no es necesario hacer el PLAB.
4. Título y expediente académico originales y traducción jurada
5. Certificado de Good Standing para demostrar que el candidato no ha sido suspendido de la práctica médica.
6. Cartas de empleo que cubran los últimos 5 años en papel con membrete del hospital, selladas y firmadas bien por el Jefe del departamento o Recursos Humanos del hospital de procedencia
7. Declaración online de aptitud física para trabajar
8. Invitación formal a asistir a la oficina del GMC de Londres para comprobación de identidad con documentos originales

## **ICU JUNIOR FELLOW HONORARY CONTRACT OF EMPLOYMENT WITH KING'S COLLEGE NHS TRUST FOUNDATION TRUST**

King's College NHS Foundation Trust is one of the largest complexes in the UK with strong links to King's College University London. We are looking for Intensive Care trainees (in the last 12-18 months of their MIR training program) who wish to work with us for three to six months as Junior Fellows as part of their MIR training program to expand their professional experience.

The Department of Intensive Care offers the possibility to come to rotate and participate in the daily activities of the ICUs with greater clinical and research activity of the city of London. For this it is necessary to obtain an honorary contract (no remuneration) with some particular requirements. The objective is to provide this possibility on a regular basis throughout the year with the ideal start dates being the first week of February or August, but there is flexibility depending on the availability of the candidates.

London's King's College Hospital is one of the country's major reference centers with currently 70 critical-care beds and in full expansion, with a capacity of up to 120 beds expected in the next two years. It is a world reference center for liver transplantation (about 250 per year) and polytrauma center.

### **"Offer and requirements"**

The Junior Fellow employment contract requires **registration with the General Medical Council** to be able to attend patients and participate in the rotation as one more member of the team in addition to **having passed a selection interview** among the candidates presented which can be remote (such video conference/ "Skype"). To get GMC registration doctors must hold the **academic IETLS**.

Our responsibility as fellowship coordinators is to provide information on the requirements, selection system and help as much as possible with the processing. As Junior Fellow, we offer not only the possibility to participate in daily clinical activity, but also in department meetings, courses, research, grand rounds, sessions on relevant topics and of course, to live in one of the most vibrant and cosmopolitan cities in the world.

In order to work in the United Kingdom, it is necessary to contact the General Medical Council (GMC). The process is not complicated but it is important to meet all the requirements. This GMC page explains in detail the collegiate process for applying for registration with a license to practice –**applying for registration with a licence to practise** – for nationals from the EEA, Switzerland and other doctors with EC rights, who graduated at EEA or Swiss medical schools and have not completed an internship.

Specialist Registration cannot be obtained directly and is not necessary at all for this position.

The requirements are as follows for the registration with the GMC are:

1. Pay the fee £ 425 and open an online account with the GMC.
2. Valid passport or DNI
3. Academic IELTS with a minimum grade of 7 in each section and a total average of 7.5. As citizens of the EU it is not necessary to do the PLAB.
4. Original academic title and transcript and sworn translation
5. Certificate of Good Standing to demonstrate that the candidate has not been suspended from medical practice.
6. Employment letters covering the last 5 years on hospital letterhead, stamped and signed either by the Head of Department or Human Resources of the hospital of origin
7. Online physical fitness statement for work
8. Formal invitation to attend the GMC London office for identity verification with original documents
